

# Underage Participant Policy

---

## **C.A.S.T.L.E. LARP Underage Participant Policy**

Version 1.5

Effective 2/1/2015

While we strive to make C.A.S.T.L.E. LARP a family-friendly game, the following Underage Participant Policy has been created to maintain the safety and enjoyment of all players. This policy applies to all players under the age of 18.

- No one under the age of 14 is permitted to participate at C.A.S.T.L.E. LARP events
- Players aged 14-15 may participate under the following conditions:
  - Legal Release must be signed by a Parent or Legal Guardian
  - Parent or Legal Guardian must accompany the player at all times
  - A “responsible party” may accompany the teen player provided that he/she is:
    - Over the age of 18
    - Has written acknowledgement from the parent or legal guardian of the player that he/she is responsible for the player at all times
  - The Teen Player may not, at any time, leave site UNLESS with parent, legal guardian, or responsible party.
- Players aged 16-17 may participate under the following conditions:
  - Legal Release must be signed by parent or legal guardian
  - The player may not, at any time, leave site UNLESS with parent, legal guardian, or responsible party.

## Underage Participant Policy

As the parent/legal guardian, I agree to allow my child/ren to participate in Live Action Role Play at C.A.S.T.L.E. LARP. I understand that participants may be exposed to graphic fantasy violence in a role play setting and crude or indecent language which may be unsuitable for children under the age of 16.

I also understand that I must agree to and sign a medical waiver in order for my child/ren to participate at a C.A.S.T.L.E. LARP event.
